[TrialPad \(\\$89.99\)](#) - TrialPad, a leading trial presentation and legal file management app, is easy, effective and intuitive. It can be used to present and annotate evidence in any trial, hearing or ADR setting.

Once the rules are set up in the app, calculations are performed, based on a customizable list of court holidays. Choose a trigger event (hearing date) and display a list of all corresponding dates and deadlines. Dates can be added to your device's native calendar or emailed from the app.



[MagicPlan \(Free\)](#) - This app lets you measure rooms and draws a floor plan just by taking pictures. You can then get the floor plan for exhibits and presentations in PDF, JPG and DXF format, or publish an interactive floor plan on the web. **[MagicPlan CSI \(Free\)](#)** measures crime scenes with menus that allow you to position and document evidence and create PDFs and graphics to use in reports.

[Fastcase \(Free\)](#) - The Fastcase app allows subscribers to the legal reference service to search its growing virtual law library on the go, in the palm of their hand – including cases and statutes from all 50 states and the federal government. Search by citation or keyword (in Boolean or natural language), or browse statute collections.



[Black's Law Dictionary \(\\$54.99\)](#) - For more than a century Black's Law Dictionary® has been the standard for the language of law. Today it's the most widely cited law book in the world. The 9th Edition contains more than 45,000 terms, alternate spellings or equivalent expressions for more than 5,300 terms, and West key numbers.



[Law Stack \(Free\)](#) - A “legal library for your pocket,” Law Stack comes preloaded with the U.S. Constitution, Federal Rules of Civil Procedure, Federal Rules of Criminal Procedure and much more. Plus, state codes can be added to your “stack” from the apps embedded collections.



[LawBox \(Free\)](#) - This legal reference and search utility features a fast full-text legal search engine with a built-in library. Download additional codes for free as needed, including code packages for Federal Rules of Appellate Procedure, Bankruptcy Procedure, Civil Procedure, Criminal Procedure, Federal Rules of Evidence and more. Hundreds of 2012 codes are available for purchase, including complete state statute sets.

[Patents \(\\$2.99\)](#) - This app allows patent litigators to enter a patent number and efficiently retrieve U.S. utility patent information—claims, title, inventors and priority information. Patents can be bookmarked and associated with matter names and numbers, and an editable history of patent numbers is maintained. Launch Safari from the app to view the full text of the specification on the USPTO's website.



[Federal Rules of Civil Procedure \(\\$.99\)](#) - This app gives you Fitz Collins Federal Rules of Civil Procedure, on your iDevice—just download and go. It includes full-text search and in-text highlighting, plus the ability to adjust font and font size for easier reading. It also includes Advisory Committee Notes. Note: Also part of the Fitz Collins Law Libe app.



[Federal Rules of Evidence \(\\$.99\)](#) - This app gives you Fitz Collins Federal Rules of Evidence on your iDevice. Content is fully offline. Dropbox integration allows you to manage multiple documents on the go.



[Evernote \(Free\)](#) - Evernote helps you remember anything and everything that happens in your life. From notes to ideas to snapshots to recordings, put your thoughts and your research all into Evernote and watch as it instantly synchronizes from your iPhone or iPad to your Mac or Windows desktop.



[Things \(\\$9.99\)](#) - Things is a beautifully focused, intuitive task manager that lets you manage to-dos, notes, due dates and projects. A smart to-do list and the scheduling feature allow you to work effectively and you can sync wirelessly with the desktop version. An update in August 2012 added Things Cloud.



[G-Park \(\\$.99\)](#) - G-Park is a simple and fast parking application. Just park your car and press the Park Me button, get lost, and then press “Where Did I Park?” to locate your car. Add notes or photos to help you remember, too.



[LinkedIn \(Free\)](#) - LinkedIn puts your professional network just a touch away. Walk into any interview or client meeting with the ability to look up the details and connect with millions of professionals. Get the latest updates and messages from your network and keep them up-to-date with your status in real-time.



[Pocket \(formerly Read It Later\) \(Free\)](#) - Pocket lets you save web pages to read later, even without an Internet connection. Add to your reading list from any device. Download the complete web page, read at text-only version in Pocket’s Article View, or both.



[Billable Hours \(\\$2.99\)](#) - Do you waste time trying to remember all the different work you performed for different clients when you record your hours? Billable Hours helps you keep track of the work you do throughout the day, making the process of recording your hours at the end of the day or week much simpler. Export daily or weekly summary reports or raw data via email.

[Quickoffice Pro \(\\$14.99\)](#) - This app offers an intuitive and easy-to-use interface for advanced editing of Microsoft Word, Excel, and PowerPoint files on your iPhone or iPod Touch, with integrated file management and convenient access to multiple cloud services. (Note: See Quickoffice Pro HD for use on iPad.)



[Citrix Receiver \(Free, requires server\)](#) - If your firm uses Citrix to host applications, you can use the free Citrix Receiver app to check your email, review documents and tune into project or matter dashboards from your iPad or any other device. Your help desk provides the URL to set up Receiver.



[Sign It! \(\\$4.99\)](#) - Open a document from your iPhone email, Dropbox or third-party app and digitally sign or fill-in forms and annotate email or export updated documents. Includes a PDF editor with form fill, date and time and rubber stamp and signature embedding.



[SignNow \(Free\)](#) - Upload any PDF or Word doc from email, Dropbox or camera, then sign with your finger and email or save the document to a free account. Fill in PDF forms, turn a picture into a PDF, get signatures from clients online or on their mobile device.



[iTranslate \(Free\)](#) and **[iTranslate+ \(\\$1.99\)](#)** - These apps translate words, phrases and text. Listen to spoken translations in over 20 languages. Use speech-to-speech translation, or use the swipe gesture to automatically paste and translate text from your clipboard. Send translated text via email or Twitter or simply copy it.



[Word Lens \(\\$4.99/dictionary\)](#) - This translation app instantly translates printed words using your built-in video camera, in real time. Built-in examples include translations in English, Spanish, French and Italian. (Note: Full-language pair packs must be purchased separately from within the app.) No network required.



[Voxer Walkie-Talkie PTT \(Free\)](#) - This app turns your smartphone into a push-to-talk (PTT) walkie-talkie. Send instant audio, text, photo and location messages to one friend or a group of your friends in real time. Your friends can listen to your message while you talk or check it later.
