[Adobe CreatePDF \(\\$9.99\)](#) - It brings the same high-quality PDF creation as Adobe Acrobat to your Android tablet and Smartphone. Convert all your Office, Photoshop, Illustrator, InDesign, Image, text and RTF files to PDF, and share the converted PDF using the Adobe CreatePDF application.



[Adobe Reader \(Free\)](#) - The global standard for reliably viewing and sharing PDF documents across platforms and devices. Access the widest range of PDF file types. Adobe Reader offers fast, high-quality interaction with PDF files on your Android.



[Astrid Task/To-Do List \(Free\)](#) - This much-loved open source to-do list and task manager is designed to help you get stuff done. It features reminders, lists, sync, a widget, task sharing, optional instant notifications and much more.



[Barnacle WiFi Tether \(Free\)](#) - Turn your phone into a wireless ad-hoc hotspot. Share your 3G with Windows, Mac/iPod/iPad, Linux and Xbox. Requires root access.



[Bump \(Free\)](#) - Bump two phones together to share photos, contacts and apps. Use Bump to share contact information and photos by simply bumping two phones together. Just open Bump, hold your phones, and gently bump your hands together—Bump will magically do all the rest.



[CamScanner \(Free/\\$4.99\)](#) - Simply take a picture of any paper document—receipts, whiteboards, notes, agreements—and CamScanner can auto-crop the image, enhance image quality and create an industry-standard PDF file. Upload documents to sharing services like Dropbox, Google Doc or Box.net, and manage them by tagging or searching.



[CamCard Lite \(Free\)](#) - CamCard is a professional business card reader and business card scanner. Simply take a picture of a business card and CamCard recognizes and saves contact information in Card Holder or your address book.



[ClockworkMod Tether \(Free/\\$4.99\)](#) - ClockworkMod Tether is a USB tether solution for Mac, Windows and Linux that allows you to use your phone's data connection to get Internet access on your desktop or laptop.



[Dictadroid \(Free/\\$1.99\)](#) - Dictadroid turns your Android phone into a professional, high-quality dictation machine and voice recorder. Use it to record voice dictations, notes, meetings, music or any other audio and share it via email, MMS or Dropbox.



[Documents-To-Go \(Free/\\$14.99\)](#) - View native Microsoft Word, Excel and PowerPoint files and attachments. Premium version unlocks ability to create and edit Microsoft Word, Excel and PowerPoint files as well as high-fidelity viewing of your PDFs.

[Dropbox \(Free\)](#) - File synchronization and sharing service that lets you take your docs, photos and videos anywhere and transfer them easily. Read documents or flip through your albums when you're out and about. Save photos or videos to Dropbox and share them with friends in just a couple of taps.



[eFax \(Free\)](#) - Create and send faxes and search and view your incoming faxes so you can act on important documents anywhere, anytime. Create customized cover sheets and use your Android contact list to populate them easily. Add search tags and archive faxes for convenient access. Forward as a fax or email. Note: Requires an eFax account.



[Evernote \(Free\)](#) - Take notes, capture photos, URLs and web pages, create to-do lists, record voice reminders—and make these notes completely searchable, whether you are at home, at work or on the go. Access and sync your Evernote account across devices.



[FlexT9 \(\\$4.99\)](#) - From Nuance, an alternative keyboard with a 4-in-1 interface that allows you to speak, trace, write or tap. Leveraging the power of Dragon Dictation, you can easily speak text content for everything from SMS and email messages to Facebook and Twitter updates, and seamlessly switch between the four modes.



[GateGuru \(Free\)](#) - GateGuru is the leading day-of-travel application that covers over 120 airports across the United States, Canada, Europe and Asia. View your Triplt and KAYAK itineraries, view or post airport security wait times and see a structured list of airport food, shops and services.



[Good for Enterprise \(Free\)](#) - Secure mobile collaboration and device management for Android devices. Allows employees to securely access, manage, save and send email and attachments. Separates personal from business while respecting privacy. Prevents data loss by providing security at the application layer. Requires back-end software.



[Google Services](#) - Popular productivity and business tools developed by Google, Inc., include Google Docs (for uploading, creating and collaborating on text, spreadsheets and more); Gmail, Google Maps, Google Reader, Google+, Google Goggles and Scholar.



[GoToMyPC \(Free\)](#) - Remotely access your work computer from anywhere. GoToMyPC for Android gives you the freedom to go anywhere you choose and connect right to your Mac or PC. Easily access your files, programs and email on the road. To use this free app you must first have a GoToMyPC subscription.



[GoToMeeting \(Free\)](#) - Increase your mobility by attending GoToMeeting sessions on your Android device. GoToMeeting is the easiest and most convenient way to attend online meetings.

[InstaFetch \(Free/\\$4.99\)](#) - Save complete web pages to Instapaper directly from your Android device, synchronize with your Instapaper account and download full contents of web pages that you want to read later. The Pro version includes Instapaper folders, full-screen mode, Evernote integration, wireless-only syncing and more.



[Join.me \(Free\)](#) - Attend your next online meeting on your mobile device with the mobile viewer in this simple screen sharing app. View someone's screen and collaborate in real time. Light and fast and makes attending a meeting as easy as touching your screen.



[LinkedIn \(Free\)](#) - Access to all your favorite LinkedIn features for networking, catching up on news feeds and getting updates from your network. Handy for looking up profiles on the go when you are headed for a meeting. Plus, keep your status up-to-date in real-time.



[LogMeIn Ignition \(\\$29.99\)](#) - Directly control your desktop computer or laptop (Mac or PC), including all of your programs and files, with a simple click.



[Mortgage Calculator \(Free/\\$2.99\)](#) - Handy tool for calculating regular, biweekly, yearly, interest only, balloon, Canadian, FHA, VA, USDA, weekly and semi-monthly loans. Features include the ability to email or export amortization. Pro version includes unlimited profiles, more loan types, news and rates from Bankrate and more.



[PressReader \(\\$29.95 per month\)](#) - PressReader delivers a visually appealing reading experience for more than 2,000 newspapers and magazines from 95 countries. Automatically download complete digital replicas of your favorite publications and read them on your Gingerbread or Honeycomb device. Various subscription plans available.



[Quickoffice Pro \(\\$14.99\)](#) - With this productivity suite, create, view and edit Microsoft Office files including Word documents, Excel spreadsheets and PowerPoint presentations. Access files remotely from Google Docs, Dropbox and other file-sharing services or from your SD card. Advanced PDF viewer included as well.



[RepliGo Reader \(\\$4.99\)](#) - RepliGo Reader enables PDF viewing, annotating and form filling. Review documents on the go by adding highlights, cross outs, underlines, sticky notes, arrows, lines, ovals, rectangles, freehand drawings and text boxes. RepliGo Reader integrates seamlessly with Gmail, Dropbox, Evernote and numerous other applications.



[Scan2PDF Mobile Lite \(Free\)](#) - Use your phone's camera to scan a document, send it to the host and get it emailed to you as a readable PDF file. Like having a scanner, photocopier and fax machine in your pocket. PDFs are saved to your phone/SD card and can be emailed directly or downloaded later.

Skype - Make free Skype-to-Skype video calls, and call phones at Skype rates on the move. Make free voice and video calls to anyone else on Skype, whether they're on an Android, iPhone, Mac or PC, as well as IMs to your friends and family.



Speaktoit Assistant (Free) - A virtual buddy for your Android that uses natural language technology to answer questions, find information, launch apps and connect you with web services, such as Google, Facebook, Twitter, Evernote, and others. Assistant works with your smartphone to get maps, search for news and images, look up weather reports, send email and much more. You can also choose Assistant's appearance and choose voices powered by iSpeech.



TripIt (Free/\$3.99) - Get peace of mind by having all your travel plans in one place. TripIt “automagically” takes all your trip details and creates one truly helpful itinerary that’s there when and where you need it—on your smartphone or tablet, synced with your calendar and online at tripit.com.



Touchdown with Exchange (Free 30-day Trial) - Email app for Microsoft Exchange or Outlook users. TouchDown syncs emails, contacts, calendar and tasks on your Android device. Customizable notifications and settings, SD card support and widgets that make it easy to see your status at a glance. TouchDown supports Exchange ActiveSync policies such as PIN, remote wipe, data encryption and storage card encryption of corporate data.



LEGAL REFERENCE APPS



[Black's Law Dictionary \(\\$54.99\)](#) - For more than a century Black's Law Dictionary has been the standard for the language of law. Today it's the most widely cited law book in the world. The 9th Edition contains more than 45,000 terms, alternate spellings or equivalent expressions for more than 5,300 terms and West key numbers.



[DroidLaw \(Free\)](#) - A one-stop shop for legal reference materials. Includes the U.S. Constitution and Federal Rules of Evidence, Civil Procedure, Criminal Procedure, Bankruptcy Procedure and Appellate Procedure. State codes, United States Code, Code of Federal Regulations, Supreme Court opinions and more are available for purchase.



[The Law Guide/Dictionary \(Free\)](#) - From the creators of the website TheLaw.com. Search, browse and bookmark over 8,500 entries and over 200 articles. Also includes legal advice forums, a lawyer directory, a job post board and more. Ad-free.



[Google Scholar \(Free\)](#) - Though not technically an app, Scholar is frequently included among lawyers' budget research options. It provides a simple way to broadly search for scholarly literature, across many disciplines and sources: articles, theses, books, abstracts and court opinions (search "legal opinions and journals" from the drop-down menu), from academic publishers, professional societies, online repositories, universities and more.



[NYSBA Mobile Ethics App \(Free\)](#) - Searchable database of ethics opinions from the New York State Bar Association Committee on Professional Ethics. Search more than 850 opinions on topics including various conflicts of interest, advertising, standards for social media and more. Opinions are keyed to the New York Rules of Model Conduct and are available for sharing via social networks or email.



[PocketJustice \(Free/\\$4.99\)](#) - PocketJustice brings the U.S. Supreme Court down to earth through abstracts of the Court's constitutional decisions and access to its public sessions. The application includes voting alignments and biographical sketches for all 110 justices. PocketJustice harnesses recordings of the Court's public proceedings to deliver hundreds of hours of oral arguments and opinion announcements.



[PUSH:legal \(Free/Subscription\)](#) - Quickly reference, access and search up-to-date statutes and cases while on-the-go. PUSH:legal is a complete legal research system in the palm of your hand, designed by lawyers for lawyers. Interactive access to fully annotated legal deskbooks replete with both statutes and case law from the state and federal level. Prices start at \$12.99 per book for a one-year subscription.



[WestlawNext Mobile \(Subscription\)](#) - Included in your subscription to WestlawNext, go to next.westlaw.com on your device and login using your same username and password to continue your research on your smartphone or tablet. Device detection ensures optimized display. Automatically syncs with the WestlawNext website and iPad app, so research in one place is easily accessed and continued anywhere.



PRE-TRIAL AND TRIAL APPS



Lawyers' Reporting Mobile (Free) - Allows you to connect with your important information instantly. Access transcripts and case files, check your schedule, find directions to a deposition, look up invoices, outstanding balances and more.



LexisNexis CourtLink (Free with subscription) - The CourtLink mobile app allows you to review recent court docket Alerts and Track activity. Set up Alerts and Tracks on the CourtLink site and then monitor them from anywhere.



Mobile Transcript (Free) - This app gives lawyers the opportunity to review deposition and court transcripts optimized for Android phones, with various interactive features such as creating a deposition summary and capturing time for billable hours.



Picture It Settled Lite (Free) - Helps litigants visualize and analyze their positions and develop successful negotiation strategies. It tracks the dollar moves along with time intervals between offers. The app then takes that offer history and extrapolates it out in both dollars and time to help you picture whether and when you might reach a deal. The actual offers are connected by solid lines and the extrapolations are dotted. Also helps calculate future offers based on the concession rates of both parties.



SECURITY APPS



[Find My Phone \(Free\)](#) - Find your lost, stolen or misplaced phone. If you lose your phone, just send it a text message and Find My Phone will reply to you with its current address and a Google Maps link to its location. Text your phone and have it ring at maximum volume for several minutes if you lose it somewhere nearby. Also, find out how much battery is remaining and get notified if somebody changes your SIM card.



[Lookout Mobile Security \(Free\)](#) - Security and antivirus app scans all new apps and confirms that they have no malware, spyware or trojans. Includes free Find My Phone, data backup and more plus the ability to schedule daily or weekly scans. Find My Phone locates your lost or stolen phone on a Google map even if GPS is turned off, then activates a loud alarm, even if your device is set to silent.



[mSecure \(\\$9.99\)](#) - mSecure Password Manager offers a convenient solution for safeguarding and syncing your important information. Ultra-secure encryption is used to protect personal information such as account numbers, usernames, passwords and more. Set a different password for each of your devices, and sync between them via Dropbox.



[Seal \(\\$2.65\)](#) - Seal adds a second layer of security to allow you to lock specific apps. With Seal you can protect any application with a password or a pattern easily, so nobody but you can open them. Stop worrying about who is reading your private messages.



[Where's My Droid \(Free\)](#) - This tracking app can turn the ringer volume up and make your phone ring or get GPS coordinates with a link to Google maps if you're not close by. Track your phone with a texted attention word or with online commander at wheresmydroid.com. Includes passcode protection, notification of changed SIM card or phone number, plus stealth mode hides incoming text with an attention word and a white/black list controls who can use the app via text.



TIME MANAGEMENT AND BILLING APPS



[CallTrack \(Free\)](#) - CallTrack logs your phone activity to your Google Calendar to help you keep track of billable hours. You can select the type of calls to log (incoming, outgoing and missed) and the calendar to log them in. You can also dump your current call log to your calendar.



[RateDriver \(Free/\\$4.99\)](#) - The RateDriver application by Tymetrix is designed to simply allow users to determine the appropriate rate one should expect to pay for attorney's fees in 51 major U.S. markets. Trial version is good for 60 days.



[TimeClock \(\\$3.99\)](#) - TimeClock makes it easy to track your billable hours as you are working and then generate invoices or spreadsheets from your time data. It's the perfect Android time tracker for contractors, lawyers or anyone who bills clients by the hour.
